#### By-Law Number 8503

A By-law to temporarily close certain roads in the Town of LaSalle to accommodate the LaSalle Holiday Santa Drive-By

**Whereas** subsection 1 of Section 11 of the *Municipal Act, 2001, S.O. 2001, Chapter 25* authorizes the Council of a municipality to pass by-laws for closing, to vehicular traffic on a temporary basis for such period as shall be specified in the by-law, all or any part of any highway under the jurisdiction of the said Council for social, recreational, community or athletic purposes or any combination of such purposes as may be specified in the by-law;

**And whereas** a Holiday Santa Drive-By event is taking place on Saturday, December 12, 2020 from 4:00 p.m. to 9:00 p.m. in the Town of LaSalle;

# Now therefore the Council of the Corporation of the Town of LaSalle hereby enacts as follows:

- 1. That the Council for the Town of LaSalle delegate to the Police Chief, or his designate, the authority to close, on a temporary basis, certain roads in the Town of LaSalle to accommodate the LaSalle Holiday Santa Drive-By as shown in Schedule 'A', on Saturday, December 12, 2020.
- **2.** That access will not be permitted to the Vollmer Culture and Recreation Complex from the Laurier Parkway exit at round-a-bout from 2:00 p.m. until 10:00 p.m.
- That access to Mike Raymond Drive from Malden Road will be single direction and barricades will be put in place on Mike Raymond Drive in front of the Vollmer Culture and Recreation Complex for single direction traffic from 3:00 p.m. until 10:00 p.m.
- **4.** That access to Mike Raymond Drive will not be permitted between Judy Recker Crescent and Diotte Street from 3:00 p.m. until 10:00 p.m.
- **5.** That Schedule "A" forms part of this By-law.
- 6. This By-law shall come into force and take effect on the final passing thereof.
