RECOMMENDATION

That Mr. William Szekely be appointed as a Building Inspector, for the Town of LaSalle

REPORT

In order to provide required building inspection services during the busy construction season, we need to have the necessary staffing to carry out the required inspections in a timely manner. As a result of the sudden departure of one of our building inspectors, we have made arrangements to obtain the services of a retired building inspector (Mr. William Szekely) on a contract basis for several weeks in July and August of this year.

We currently have a similar arrangement with Mr. David Gibson, who has provided these services to the Town on an as needed basis for the past several years.

We are requesting that Mr. William Szekely be appointed by by-law as a building inspector for the Town, so that he can provide these required services as needed during the busy seasons of the year when additional resources are needed.

BY-LAW NO. 8038

By-law to appoint Building Inspectors.

WHEREAS Section 3(2) of the Building Code Act, R.S.O 1992 provides that the Council of each municipality shall appoint a Chief Building Official and such inspectors as are necessary for the purpose of the enforcement of this Act in the areas in which the municipality has jurisdiction; and

WHEREAS Brian Geary has been appointed as Chief Building Official by By-law Number 6865; and

WHEREAS it is deemed necessary to appoint additional inspectors to provide needed assistance to the Chief Building Official;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF LASALLE HEREBY ENACTS AS FOLLOWS:

- 1. That Bill Szekely be appointed Building Inspectors for the Corporation of the Town of LaSalle.
- 2. That this by-law shall come into full force and effect upon the final passing thereof.
