Thank you for the opportunity to provide you with a quote to replace part of the 12 inch Storm Sewer, between 207 Martin Lane and 217 Martin Lane, LaSalle, Ontario

**The process here is to remove and replace the compromised Storm Sewer that is in close proximity to the Garage and is allowing water to access the Drainage System around the house at 207 Martin Lane**

***Scope of Work:***

- Plug off existing 12 inch Storm Drain, at the Break Wall and Plug off the 6 inch Drain on the North Side of the Catch Basin at the road
- Dewater Storm Sewer
- Machine and Hydro Excavate and remove existing 12 inch Big "O" Storm Sewer, 8 Metres South of Catch Basin for approximately 20 metres towards Canal
- Set up Dewatering Equipment to facilitate Gravel Bedding, Compaction and Installation of New 12 inch SDR 35 PVC Pipe
- Place 30 MPA Cement around the New Pipe for 1 Metre, from connection of Existing Storm Sewer and New Storm Sewer, as a Water Dam
- Continue Dewatering until the Pipe is backfilled
- New pipe will be backfilled with Granular "A" Gravel for 1 foot above new Pipe and Mechanically Compacted
- Existing Fill will be used to complete Backfill to Grade and will be compacted and rough graded
- Replacement of Landscaping and Fence will be completed by Homeowner
