Subject: LaSalle Rowing Club Riverdance Ontario Trillium Grant Application

#### Recommendation

That the report of the Deputy CAO dated September 10, 2021 (PW-30-2021) regarding the LaSalle Rowing Club Riverdance Ontario Trillium Grant Application be received and that Council support and approve submission of this grant application by the LaSalle Rowing Club.

#### Report

The LaSalle Rowing Club has approached the Town to apply for the Ontario Trillium Grant to make the Riverdance facility more accessible.

Town adminstraiton has been working with the LaSalle Rowing Club and we have developed a proposed concept plan showing the proposed changes (concept attached). A summary of the modifications are as follows.

- An existing storage room will be enlarged and converted into a fully accessible washroom, with proper lifting mechanisms.
- Several doorways will be expanded to meet all current accessibility codes and will be changed to have mortised door openers.
- An existing, inadequate accessible washroom will be converted into a storage room.
- All associated architectural fees.

Since the Town is the owner of the building, the LaSalle Rowing Club requires a resolution and approval from the Town of LaSalle Council to support their application.

If the grant is successful, there will be some disruption to the facility and affect use of the facility, however, this will be coordinated once we progress to that stage.

Furthermore, administration is recommending that an agreement be entered into by the Town and the LaSalle Rowing Club about how funds are transferred, use of the facility, etc.

## Consultations

Discussion have occurred between the Town's internal departments and all affected departments are in support of these proposed changes.

## **Financial Implications**

The overall modifications to the Riverdance facility will be in the range of \$250,000.00. This proposed project will not cost the Town any money and the total cost will form part of the LaSalle's Rowing Club Ontario Trillium Grant application.
