Subject: Investing in Canada Infrastructure Program: Green Stream Grant Approval

Recommendation

That the report of the Manager of Engineering dated October 12, 2022 (PW-17-2022) regarding the Investing in Canada Infrastructure Program: Green Stream Grant Approval, be received.

Report

The Investing in Canada Infrastructure Program (ICIP): Green Stream is a cost-shared infrastructure funding program between the Federal and Provincial Governments. The focus for this stream of funding was on watermain projects. The Town applied and was successful for watermain replacement along Reaume and Bouffard. The work will involve replacing the existing 2,800 metres of watermain on Reaume Road from Malden Road to Milford Avenue and 1,420 meters on Bouffard Road from Malden Road to Matchette Road. The upgrades will include; increasing the diameter of watermain, replacing side street connections, installing 22 new fire hydrants and 39 gate valves.

The Public Works Department issued a Request for Proposal (RFP) for consulting services for design, contract administration and inspection in August and reviewed all submissions in September. Through that process the successful bidder was LEA Consultants. We are anticipating tendering the construction portion of work in Winter 2023 which will allow for a competitive bidding process. The results of that tendering process will be reported to Town Council.

Financial Implications

The Investing in Canada Infrastructure Program (ICIP): Green Stream Grant is for 73.33% of the project cost up to a maximum \$2,984,666. The anticipated project estimate is approximately \$4.5 million. The balance of approximately \$1.5 million would be requested to be funded from the Water Reserve in the 2023 budget process. Both Finance and Public Works support using the reserve funding to complete this work.
