1. Wyoming East Apartment Development – Application to Remove the Holding Provision

Kevin Miller and Larry Silani, MillerSilani Inc., appeared before Council on behalf of Timberland Homes and spoke to the Application for Holding (H) Removal to permit a new 5-storey, 38 unit condominium building.
