Subject: Adopt-a-Trail Program

Recommendation

That the report of the Director of Public Works dated October 14th, 2022 (PW-44-2022) regarding the implementation of an Adopt-a-Trail program be received.

Report

In Summer of 2022, Administration presented a report to Council for information on potential Adopt-a-Street or Adopt-a-Trail programs for the Town of LaSalle. The report detailed the measures and risks that would be required to implement a robust Adopt-a-Street/Trail program. Council had provided direction to Administration to review the option of a more simplified version of an Adopt-a-Trail program.

Administration is recommending the implementation of an Adopt-a-Trail program has the following elements:

- allows non-profit organizations to select from a list of 7 trail sections that are in and around the Town Centre area (map attached)
- encourages at least two cleanup days per year, spring and fall
- have an agreement with the organization for a 3 year period
- the Town would provide signage at various locations on the pathway recognizing the group
- the Town would provide garbage bags to the group, and remove the garbage after the clean up is complete
- the groups would be required to read and agree to a waiver that provides the group information on safety, responsibilities, roles for the participants
- allows groups to make the request through the Town's website

Administration will monitor the program for the first few years, and if changes or improvements are needed, those can be brought to Council at a future time.

For promotion of the program, and through assistance from the Strategy and Engagement Department, the Town will focus and promote one of the clean-up days to be on Earth Day, a day in which the Town currently promotes. The recommended second clean-up day would be suggested for September.

Existing Town resources will be able to administer the program, and the uptake by user groups will dictate the amount of time the various departments will need to allocate. Some tasks include:

- Field contact person from the Town (PW - Parks)
- Administer requests/coordinate clean-ups (PW and C&R)
- Drop off and pick of garbage bags (PW - Parks)
- Installation and removal of signs (PW – Roads)
- Promotion of the program (Strategy and Engagement)
- Update Health and Safety Sign Off Form (PW and Legal)

Consultations

Public Works worked in consultation with the Strategy and Engagement Dept, Culture and Recreation Dept.

Financial Implications

There are minimal costs associated with this program. Signs and garbage bags can be absorbed in the current operating budget.
