Subject: Extension of the Agreement for the supply and use of water

#### Recommendation

That the report of the Director of Finance/Treasurer dated November 18, 2022 (FIN-29-2022) regarding an Amendment and Extension Agreement for the supply and use of water be received;

And that Council approves the entering into an Amendment and Extension Agreement between the Town of LaSalle and Windsor Utilities Commission for the supply and use of water effective December 31, 2022 and authorizes the Mayor and Clerk to execute the agreement.

#### Report

As Council may be aware, the Town entered into an agreement with the Windsor Utilities Commission (WUC) for the supply and use of water on January 1, 2018 for an initial term of five years, with the ability to renew for further terms of five years (current term expires December 31, 2022).

The Town's Director of Finance and Director of Public works have been working with WUC administration on the terms of the renewal since August 2022. The Town is requesting some changes in the agreement to include an increase of the water usage capacity limit. Although the Town is currently well within its current capacity limit of 22 mega litres per day (maximum daily flow), this proposed change will ensure sufficient water supply to service the projected Town population into the future. The WUC is working on pricing to accommodate this change request which is taking some time to complete as it is not a simple calculation. As a result, the Town administration and WUC administration have agreed that it is best to extend the existing agreement for a sixmonth period as the final details of the renewal agreement are completed. The sixmonth extension is attached as appendix A.

Administration will report back to Council in the first half of 2023 once the terms of the renewal are drafted between the Town and the WUC.
