The purpose of the Meeting to Consider is:

- to have the Engineer present their report to Council;
- to consider the technical merits of the report;
- for Council to decide whether or not to proceed with the project; and
- to provisionally adopt the report by by-law, if Council decides to proceed,

Please note that there is no right to appeal assessments at the Meeting to Consider. Those appeals can be made at a later time in the procedure, when the matter goes before the Court of Revision.
