RECOMMENDATION:

Based on the information provided within this report, it is recommended that Lot 105 and PT Block "A", on Plan 661 be declared surplus and disposed of in accordance with municipal policy.

REPORT:

This report is intended to provide members of Council with recommendations regarding a request that has been received to purchase Lot 105 and PT Block "A", on Plan 661, as depicted on Figure 1.

The Applicant has requested to purchase the subject Town owned lands to increase the size of his existing residential property at 145 Elsworth Avenue in order to construct a new accessory garage.

It should be noted that the owners owns both 145 and 155 Elsworth Avenue. If Council agrees that the subject lands are surplus, the owner will have 70 feet (approx.) between the two existing homes. As the home at 145 Elsworth Avenue does not have an attached garage, the increased side yard restrictions would as a result reducing the size of any potential lot to approximately 55 feet and a rezoning or minor variance would be required along with a severance approved at the Committee of Adjustment, to create a potential lot.

Town Staff have reviewed the Applicant's request, and have determined there is no municipal need for this lot, and it can be disposed of in accordance with municipal policy.


