Subject: Alternating Parking Request – Sacred Heart

Recommendation

That the report of the Manager of Roads and Parks dated April 11, 2024 (PW-10-2024) regarding the request for alternating parking on Sacred Heart be received;

And that Council approves the implementation of alternating parking on Sacred Heart from Michigan, moving easterly to end;

And that the corresponding by-law be adopted at a future Council Meeting.

Report

The Town has received a request to implement alternating parking on Sacred Heart, from Michigan, easterly to end. (See attached map)

Administration has had an opportunity to review this location and review the warrants of implementing alternating parking in the area. As such, it is confirmed that the location meets all criteria set out by the Town of LaSalle to implement alternating parking including:

1. The classification of the road is residential;
2. Is in a residential area;
3. The location includes curb;
4. Road width must does not exceed 12 meters;
5. Posted speed \leq 50 km/hr;
6. Specific roadway not considered within last 36 months.

The Town also supports implementing alternating parking from an operational perspective. Access to residential areas for larger vehicles including Fire, Garbage

Collection and Public Works vehicles can be challenging when cars are parked on both sides of residential roads.

Therefore, it is recommended to implement alternating parking on Sacred Heart, from Michigan, easterly to end.

Consultations

Public Works has discussed this with the LaSalle Fire and all departments within Public Works. As such, all expressed concurrence with this recommendation to ensure equipment can easily access areas of the Town in the event of an emergency, and maintenance operations.

Financial Implications

The cost to install the signs will come from the approved Roads Department budget.
