Subject: 2024 Alternating Parking Request - Oakridge

Recommendation

That the report of the Manager of Roads and Parks dated August 2, 2024 (PW-31-2024) regarding 2024 alternating parking on Oakridge Street be received;

And that, Council approves the implementation of alternating parking on Oakridge Street, from the east intersection at Reaume Road, to the West intersection at Reaume Road for the entirety of Oakridge Street.

Report

The Town has received a request to implement alternating parking on Oakridge Street.

Administration has had an opportunity to review this location and review the feasibility of implementing alternating parking in the area. The location meets all criteria set out by the Town of LaSalle to implement alternating parking, including:

- 1. The classification of the road is residential;
- 2. It is in a residential area:
- 3. The location includes a curb:
- 4. Road width does not exceed 12 meters:
- 5. Posted speed is less than or equal to 50 km/hr;
- 6. Specific roadway not considered within the last 36 months.

The Town also supports implementing alternating parking from an operational perspective. Access to residential areas for larger vehicles including Fire, Garbage

Collection and Public Works vehicles can be challenging when cars are parked on both sides of residential roads. Therefore, Administration recommends that alternating parking be implemented on Oakridge Street.

Consultations

Public Works discussed the request with the LaSalle Fire Service and all departments within Public Works. As such, all agreed with the recommendation to ensure equipment can easily access areas of the Town in the event of an emergency, and maintenance operations.

Financial Implications

The cost to install the signs will come from the approved Roads Department budget.
