Report:

The 2017 LaSalle Craft Beer Festival was held on Friday, October 6th and Saturday, October 7th. Due to significantly high winds, the decision was made mid Saturday to cancel the remainder of the beer festival to protect the safety of everyone attending and involved with the festival. As a result, advance ticket sales for Saturday were fully refunded and 50% of vendor payments were refunded. The resulting deficit for 2017 amounted to \$13,798.38. The accumulated deficit as at December 31, 2017 amounts to \$357.23, as there was a surplus of \$12,802.30 from the 2016 festival.

Although the 2017 festival resulted in a deficit, it was significantly less than the anticipated \$20,000 deficit. This is due to the significant turnout to the festival on Friday night and the efforts put in by Town staff to negotiate a reduction in various festival costs (ie. tent and washroom rentals).
