Subject:	Civil Marriage Solemnization Service			

RECOMMENDATION:

That the report of the Director Council Services/Clerk dated January 28, 2018 (CL-9-18) respecting the appointment of the Executive Assistant to the Clerk and Council Coordinator as civil marriage officiants in accordance with S. 228(4) of the *Municipal Act, 2001* BE APPROVED and consideration BE GIVEN to the necessary by-law during by-law stage.

REPORT:

In January 2016, Council approved By-law 7865 to authorize civil marriage solemnization services in the Town of LaSalle and appointed the Deputy Clerk and Chief Administrative Officer, in addition to the Clerk, as officiants during the tenure of the their positions.

Civil marriage services have proven popular and in order to effectively deliver the service, it is recommended that two additional persons be delegated authority to offer the service under S. 228(4) of the *Municipal Act, 2001*: Linda Jean, Executive Assistant to the Clerk and Rosa Miceli, Council Coordinator. These individuals will be trained by the Clerk to perform the ceremonies along with other administrative duties such as completion of the Record of Solemnization of Marriage and Marriage Register and forwarding of official documents to the Ontario Registrar General in Thunder Bay. A By-law to authorize same is attached.

BY-LAW 7865

A BY-LAW TO AUTHORIZE CIVIL MARRIAGE SOLEMNIZATION SERVICES IN THE TOWN OF LASALLE

WHEREAS Ontario Regulation 385/04 provides for the authorization of the Clerk to solemnize marriages with the authority of a licence;

AND WHEREAS under Section 10 (1) of the Municipal Act, 2001, S.O. 2001 c.25, as amended, a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

AND WHEREAS the Council of The Corporation of the Town of LaSalle deems it desirable to have civil marriage solemnization services performed in the Town;

NOW THEREFORE the Council of the Corporation of the Town of LaSalle hereby enacts the following:

- THAT the Council of the Corporation of the Town of LaSalle directs that Civil Marriage Solemnization Services be implemented within the Town of LaSalle;
- THAT Council recognizes that Brenda Andreatta, Clerk, is authorized to solemnize marriages for as long as she holds the position of Municipal Clerk as set out under Ontario Regulation 285/04 and the Marriage Act, R.S.O 1990, Chapter M.3 for the Province of Ontario;
- THAT Council hereby further supports the Municipal Clerk delegating the authority to
 provide civil marriage solemnization services to the Deputy Clerk, Agatha Armstrong,
 for as long as she holds the position of Deputy Clerk with the Town of LaSalle and to
 Kevin Miller, Chief Administrative Officer for as long as he holds the position of Chief
 Administrative Officer and Deputy Clerk;
- THAT this by-law shall come into force and take effect on the day of the final passing thereof.
