## RECOMMENDATION:

That the entire alley be declared surplus as it is not required for municipal purposes.

## REPORT:

This report is intended to provide members of Council with a recommendation regarding a request that has been received to close and purchase a portion of a municipally owned alley. Mr. & Mrs. Clayden wishes to purchase a portion of the alley located to the rear of their dwelling at 355 Laurier Drive, to increase the size of their yard for a new landscaping design.

It is recommended that the entire alley be disposed of in accordance with Council adopted policies and, that an easement be reserved over the entire alley for above ground services. It is further suggested that each of the owners on south side of Lafferty Ave. (302 Lafferty Ave. to 390 Lafferty Ave.) and north side of Laurier Dr. (301 Laurier Dr. to 375 Laurier Dr.) be required to purchase the portions of the alley to the rear/side of their properties or the Town will require the removal of all buildings, and fences illegally constructed on the municipal property. Figure 1 is attached depicting the property that is deemed surplus.

All owners will be responsible for their proportional share of the land, surveying and legal expenses. The Town Solicitor will follow Council adopted policy and protocol when dealing with the sale and conveyance of the subject property. This matter will be brought back Council prior to the completion of this alley closing process at a public meeting.


