Report

In December of 2019, the Town tendered the Vollmer Culture and Recreation Complex outdoor festival electrical project.

This project was pre-approved by Council prior to the 2020 budget presentations in order to start work on the design phase of the contract, and start construction early in 2020. The contract is scheduled to be complete prior to the 2020 Strawberry Festival in June.

Bids for the Tender we received on January 15, 2020 through the Bids and Tenders website. The results are as follows:

Mid South Contractors ULC	\$147,772.93
Vince Ferro Construction	\$169,177.00
Vollmer Inc.	\$178,538.00
Jones Group	\$182,949.38

All Tenderers submitted the required \$25,000 Bid Bond.

The low bidder, BXF Infrastructures Inc., has indicated that they are prepared to proceed with this project in accordance with the Contract Documents and their tender submission.

It is recommended that the tender be awarded to BXF Infrastructures for the Total Tender Price of \$136,358.45 (excluding applicable taxes) and that Council authorize execution of a contract with BXF for this project.
